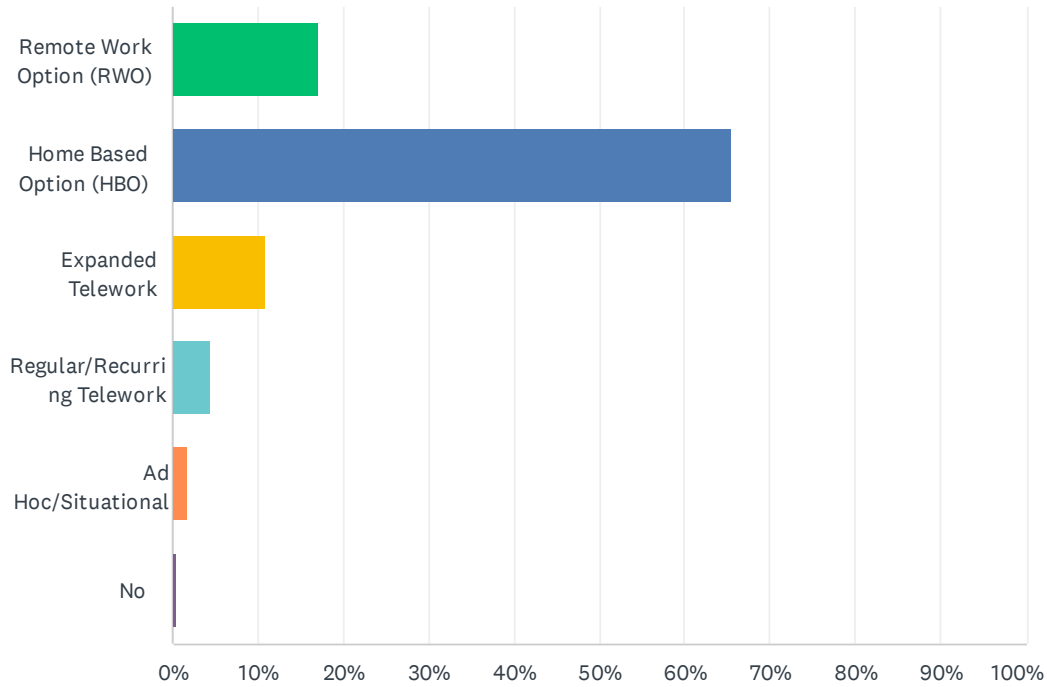


Q1 Do you currently use a telework option?

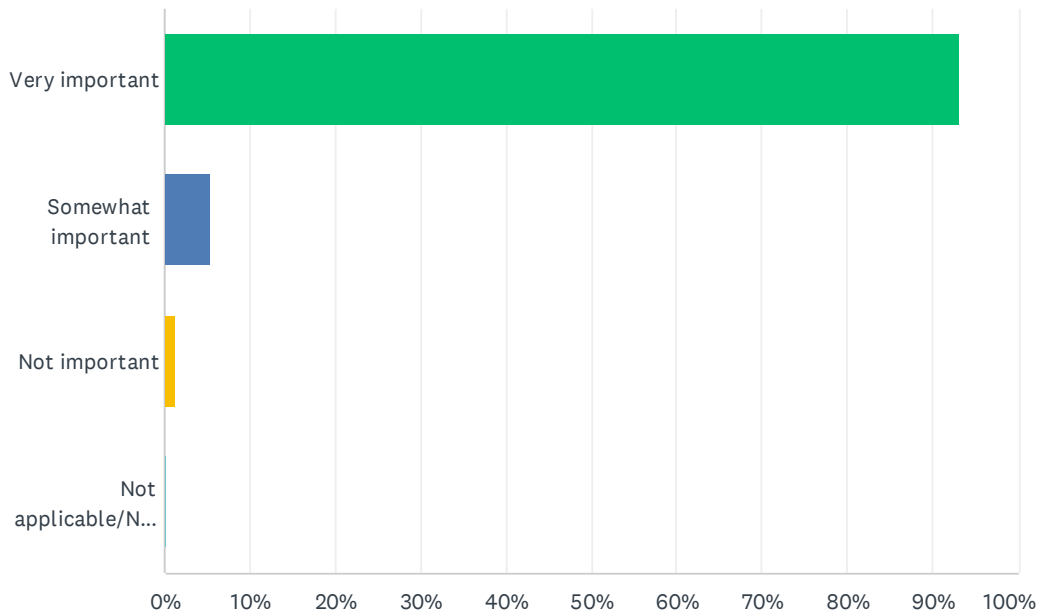

Q2 How important is your telework benefit to you?

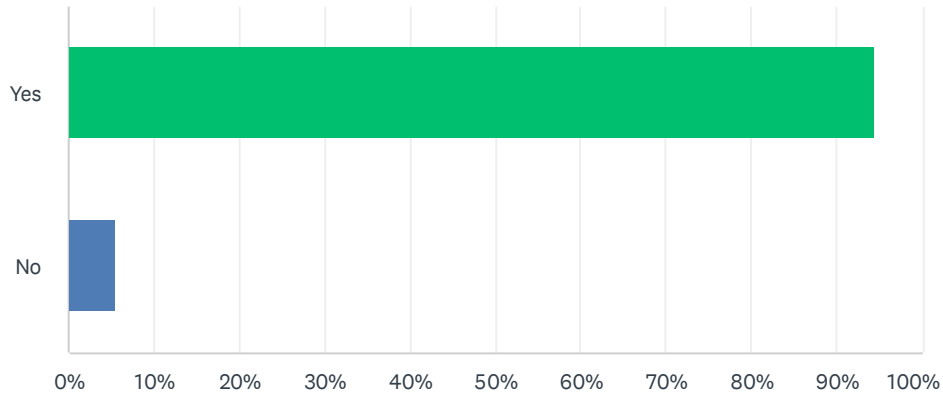

Q3 Do you think the FDIC’s proposal to significantly reduce telework will make it harder for the agency to recruit and retain employees?

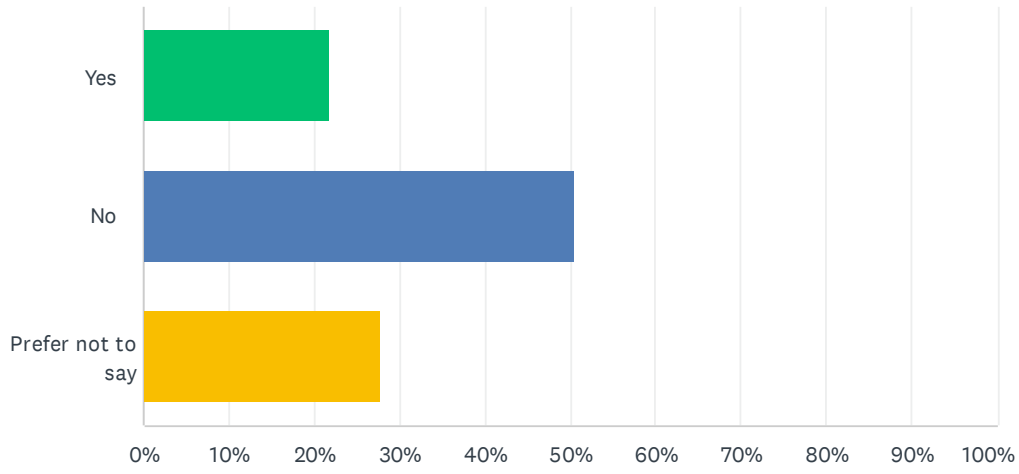

Q4 Are you currently looking for a job outside of the FDIC?

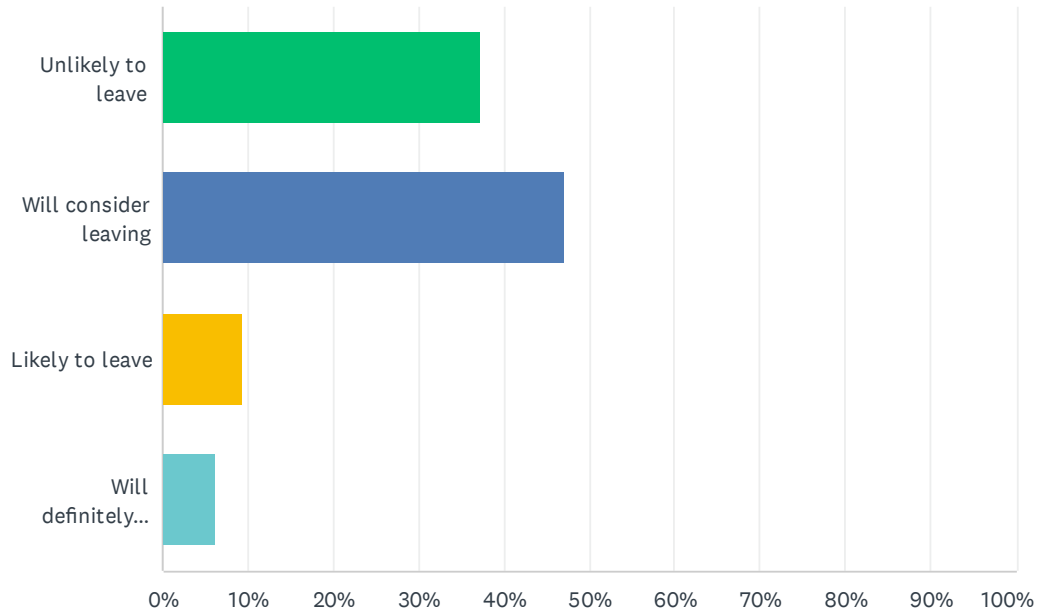

Q5 Would the FDIC’s proposed office reporting requirement cause you to consider leaving the FDIC?

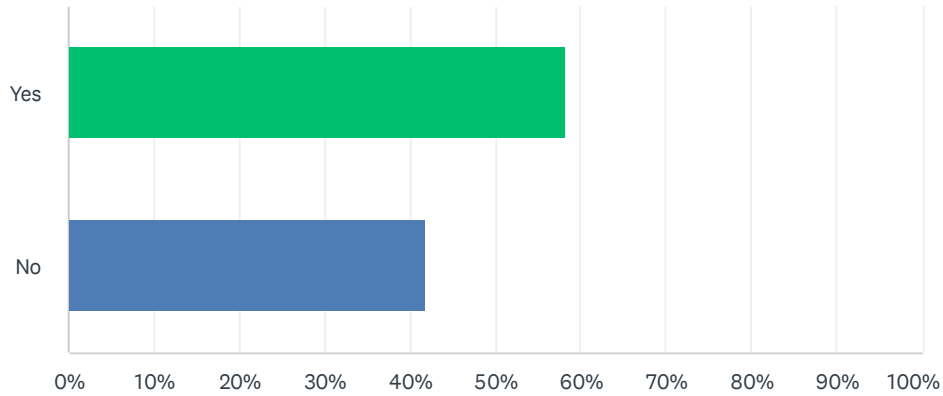

Q6 Have you told your supervisor and/or other management officials about your concerns over the proposed reporting requirement?

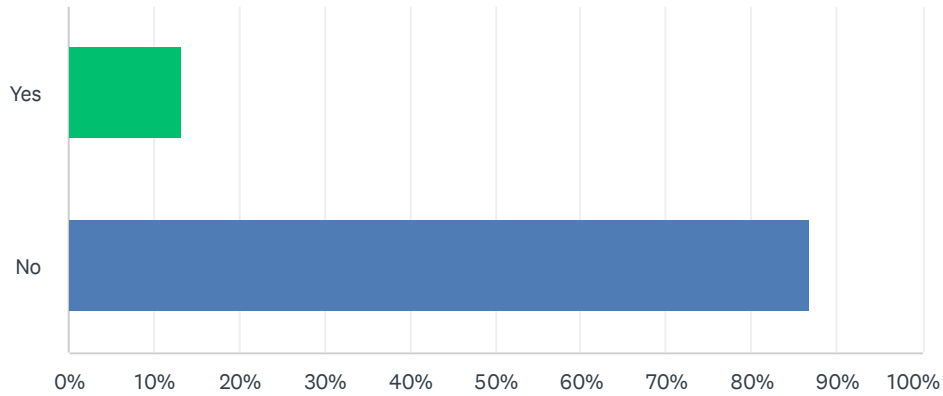

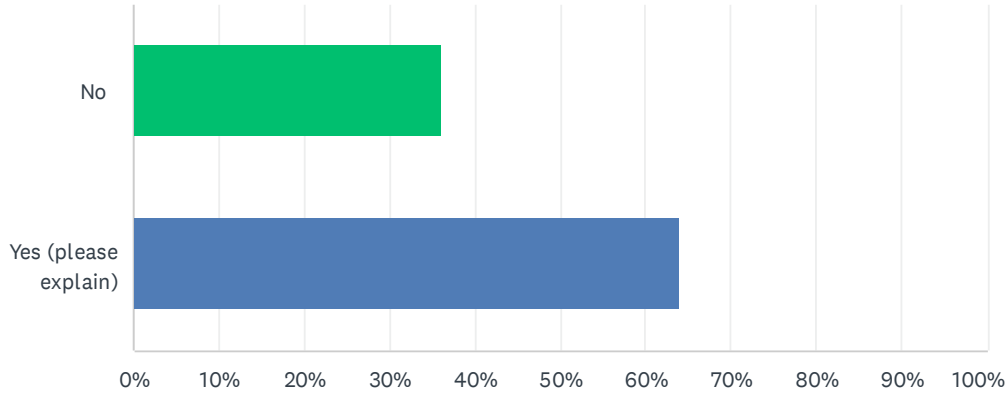

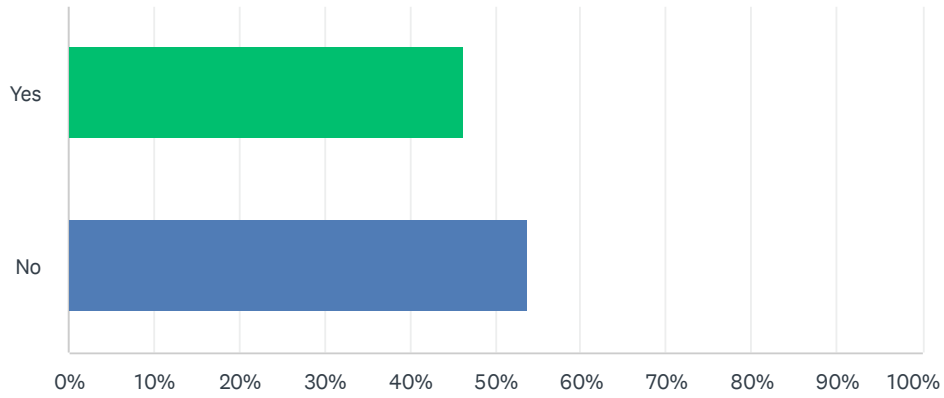

Q9 Did you move or accept a new position at the FDIC within the last three years?

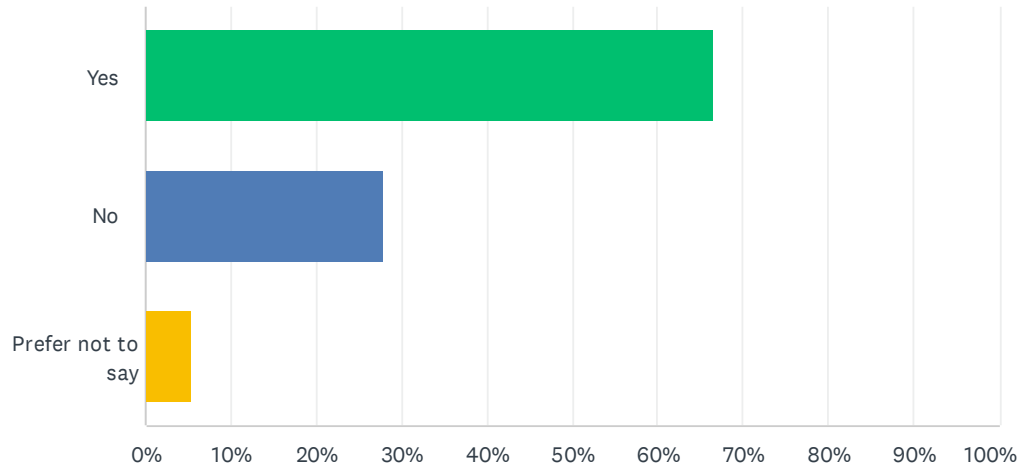

Q10 Did you discuss the office reporting requirements with your supervisor before you moved or took a new position?

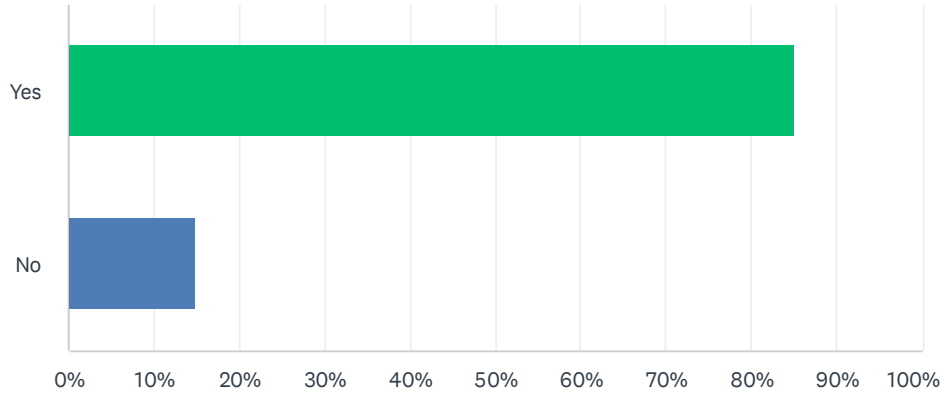

Q11 Did they provide assurances that the need to report would be infrequent?

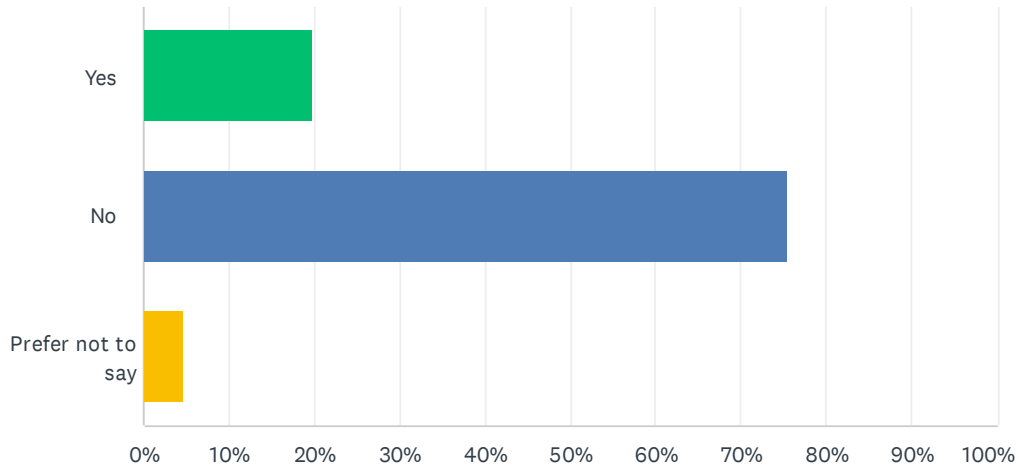

Q12 Are you currently eligible to retire?

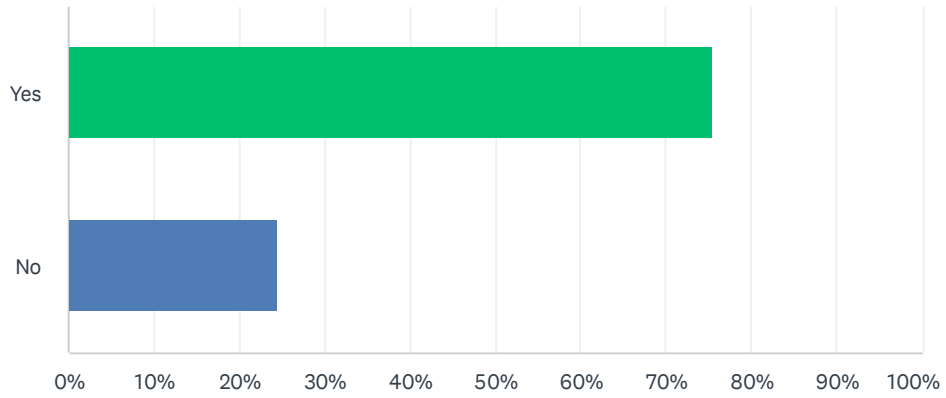

Q13 Would the FDIC's proposed office reporting requirement cause you to consider retiring?

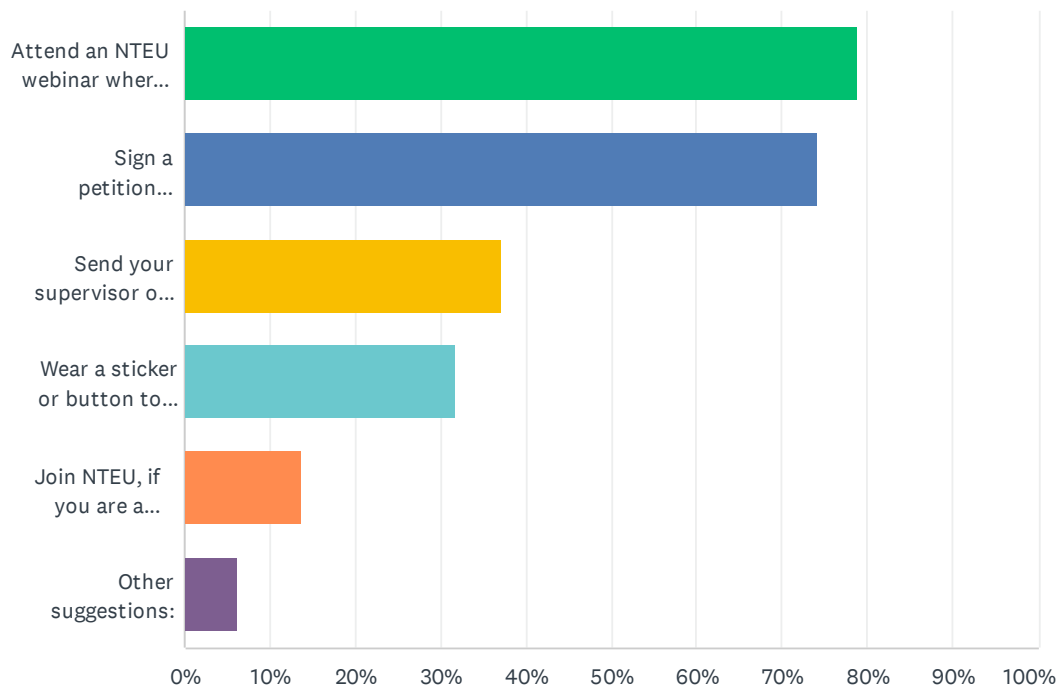

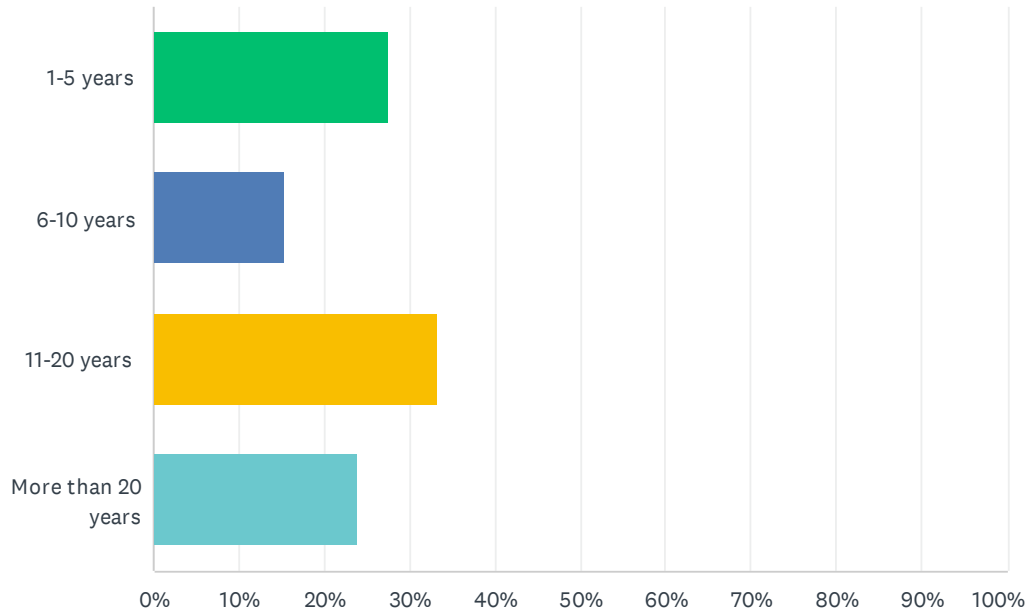

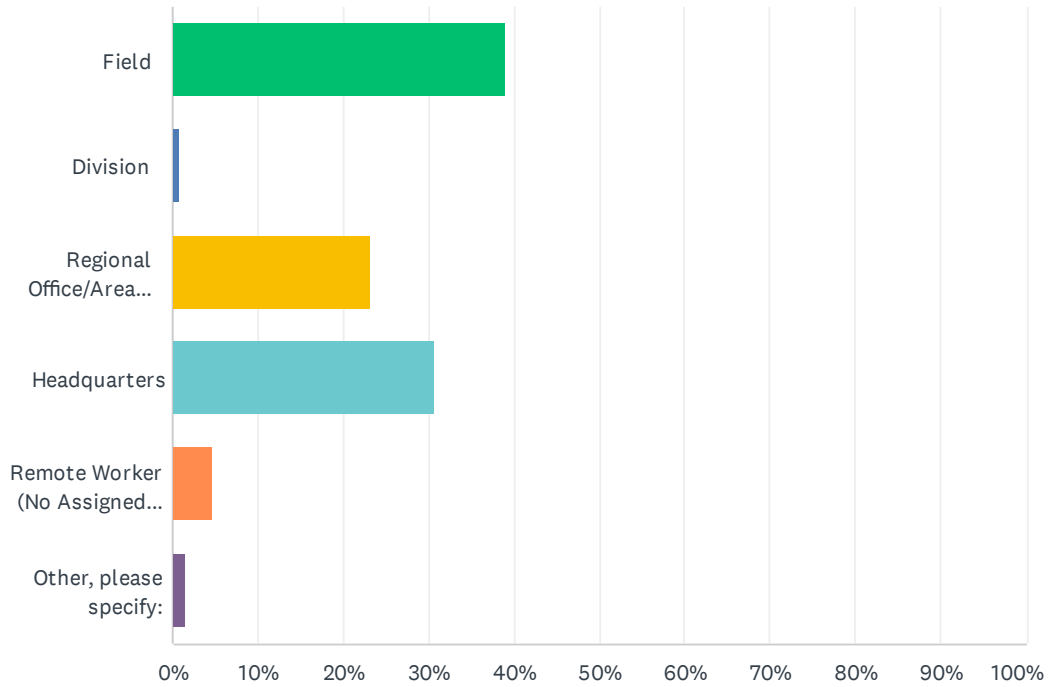

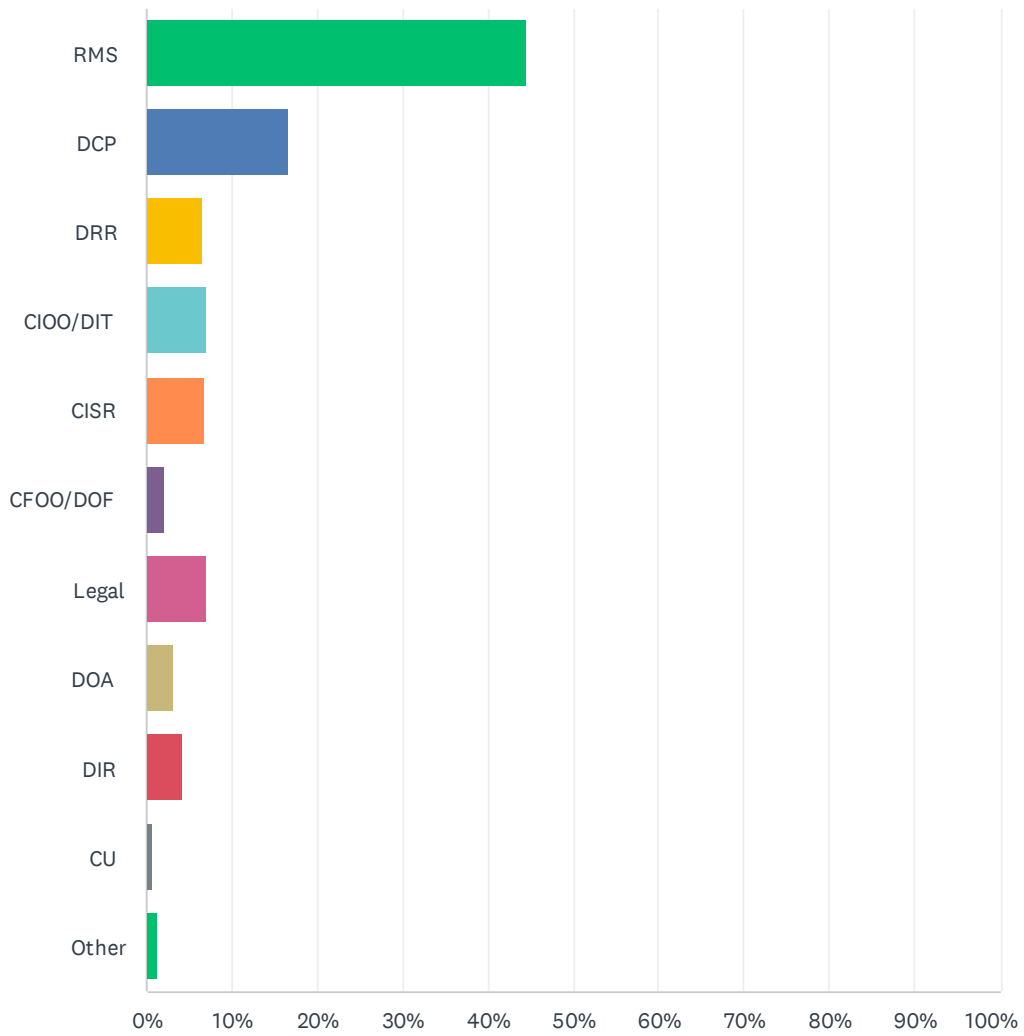

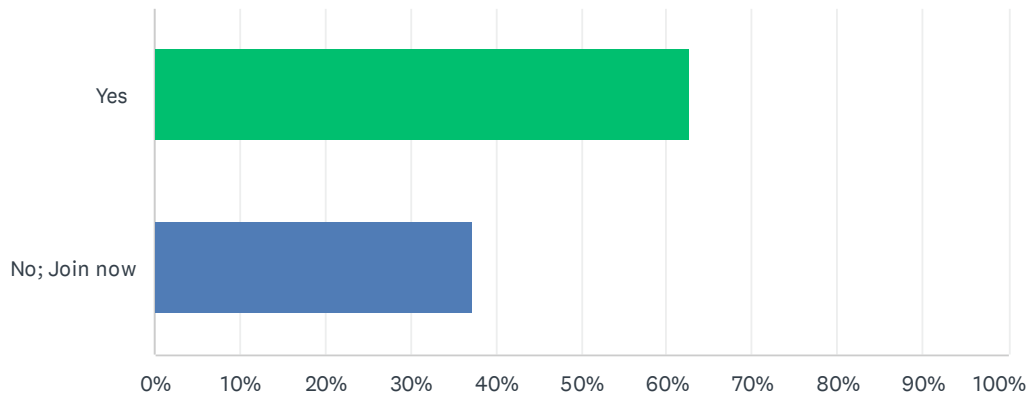
